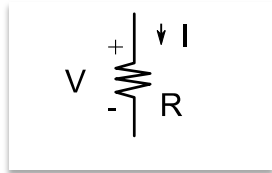

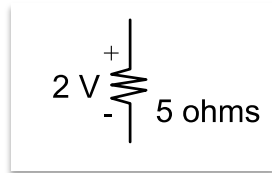

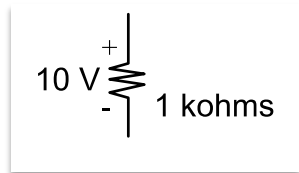

当一个 5 Ω、¼ W 的电阻两端加上 2V 电压，会产生什么结果？



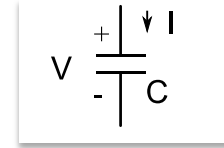

当一个 1 kΩ、¼ W 的电阻两端加上 10V 电压，会产生什么结果？



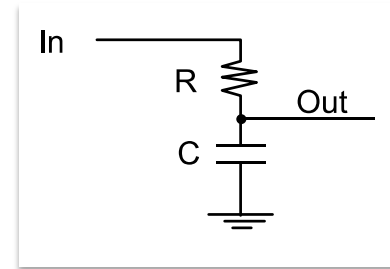
